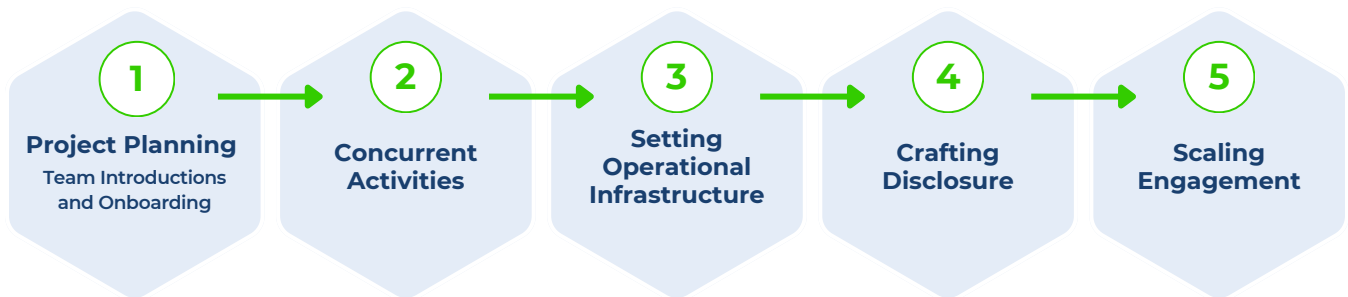

Schedule

The project schedule includes key phases that are coordinated with the client and subject to change. Timing may vary from 12-18 months based on the actual scope contracted.
