## What is NYSEERDA?

The New York State Energy Research and Development Authority is a state agency that provides funding and incentives to help NY organizations advance sustainability. Environ is a trusted NYSEERDA partner.

## What is the OsEM Program?

NYSEERDA funds dedicated energy expertise for your organization. An Environ engineer acts as an extension of your team—identifying efficiency opportunities, unlocking incentives, managing compliance, and reducing costs.

## How much funding is available?

- Up to 75% of costs covered (capped at \$200,000 over the engagement period).
- Nonprofit hospitals and safety-net facilities may qualify for 100% funding.
- Applications open until December 31, 2025, or until funds are exhausted.

## Who is eligible?

### To qualify, your facility must:

- Be located in New York State
- Pay into the System Benefits Charge (SBC) on your utility bill
- Demonstrate a commitment to reducing energy use and improving performance

### Eligible facility types include:

- Commercial buildings
- Industrial and manufacturing sites
- Educational institutions
- Healthcare facilities
- Municipal and public buildings

- Track energy performance with data-driven tools
- Engage staff across departments to support initiatives
- Align energy goals with operations and budgets
- Provide ongoing expertise to sustain improvements
